## Fishing at Alder Stream Wilderness Preserve

To obtain fishing permission for Alder Stream Wilderness Preserve read the rules below, fill out your information, and sign on the signature line. Then send your permission form to Northeast Wilderness Trust, 17 State Street, Suite 302, Montpelier, VT 05602, and you will receive your permission letter in the mail. ## 1. Tackle and Methods:

Nontoxic lures and sinkers, including jig heads, are required for all fishing. No lead.

Artificial lures only. No live or dead organic bait of any kind.

Hard lures only. No soft plastic lures.

Barbless hooks only. Barbed hooks must be pinched before being attached to a fishing line.

No chumming, chunking, advanced baiting, or use of fish traps or bait traps allowed.

- 2. The use of motorized and mechanized vehicles (including ATV's, dirt-bikes, bicycles, etc.) on the property is prohibited.
- 3. Trapping, baiting, blinds, or structures of any kind are strictly prohibited on NEWT property.

- 4. Dogs are prohibited on the Alder Stream Wilderness Preserve.
- 5. Cutting of vegetation or trees for any reason is prohibited. Anglers found to have cleared vegetation or trails will have their permission revoked, and will be expected to reimburse NEWT for the value of the trees cut at landscape appraisal rates.
- 6. No commercial angling or guide services.
- 7. Trail camera use by the public is prohibited.
- 8. Anglers assume all liability and responsibility for all of their actions and inactions while on NEWT Property.
- 9. Anglers agree to always conduct themselves in a safe, legal, and ethical way.
